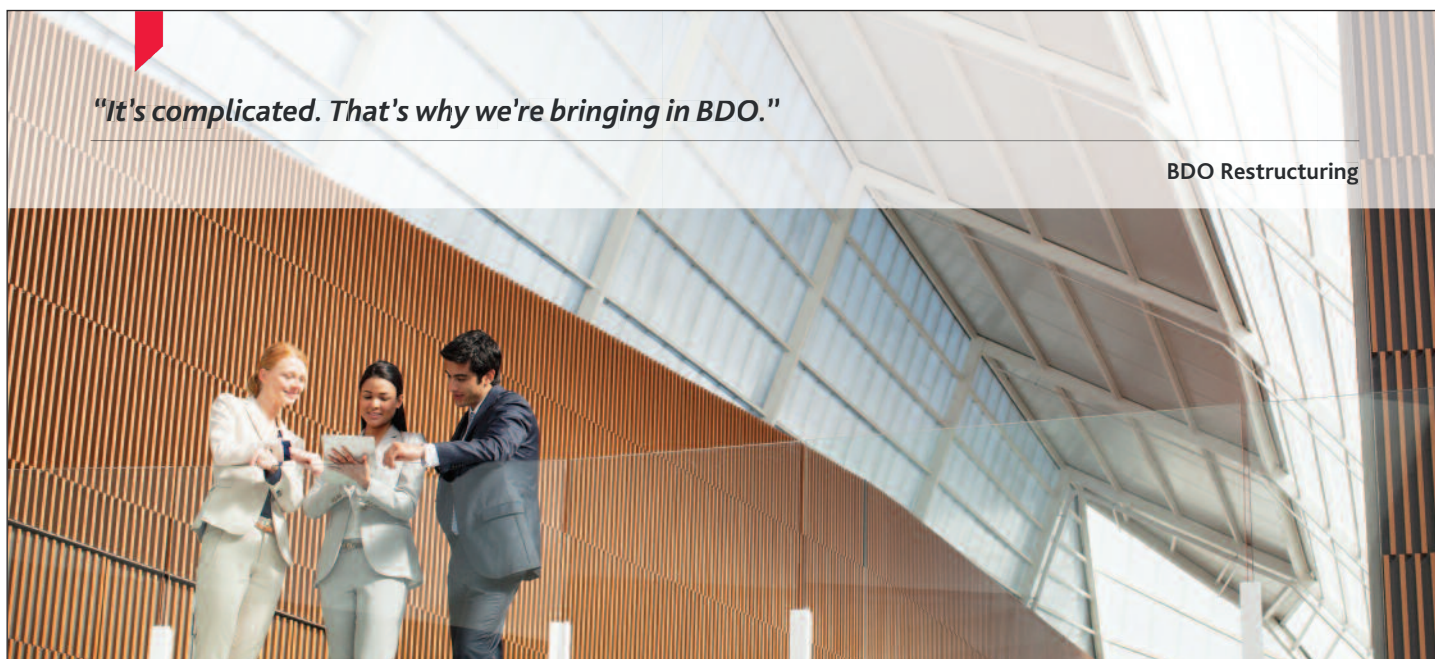

You will be warmly greeted by the Ljubljana Dragon. The legend is that Ljubljana was founded by the Greek mythological hero Jason and his companions, the Argonauts, who had stolen the golden fleece from King Aetes and fled from him across the Black Sea and up the Danube, Sava and Ljubljanica rivers. They stopped at a large lake in the marsh near the source of the Ljubljanica, where they disassembled their ship to be able to carry it to the Adriatic Sea, put it together again, and return to Greece. The lake where they made a stop was the dwelling place of a monster. Jason fought the monster, defeated it and killed it. The monster, now referred to as the Ljubljana Dragon, found its place atop the castle tower on the Ljubljana coat of arms.

It is this determination that makes Slovenia the perfect place for our 15th EECC Conference! Slovenia had a high number of insolvent companies as a result of the 2008 global financial crisis, features of restructuring procedures not suited and no preventive procedures available. In the last couple of years, Slovenia introduced preventive restructuring procedures for medium and large-size companies, simplified reorganization procedures for micro and small-size companies and improved access to reorganization proceedings for creditors. These reforms increased the number of successful reorganization cases and ranked Slovenia as number 9 at Resolving Insolvency (World Bank Doing Business Report 2019), with an 88.7 cents on the dollar recovery rate, 0,8 years and 4% of the estate cost.

The EECC Conference will bring you fresh knowledge, widen your network, stimulate your innovative self and expand your vision while providing a relaxing and memorable time in this beautiful city. We are very excited about this event and look forward to welcoming you in Ljubljana. Registration will soon be open on our website. HOW TO GET TO THE CONFERENCE VENUE

The hotel is 30km from Ljubljana International Airport and can be reached:

By public transportation:

Bus stop: Line 6, 8, 11, 18

By shuttles:

GoOpti, Nomago and Ride2. The tickets (€9) can be bought in the arrivals area waiting hall.

By taxis: Approx. €25.

The Ljubljana Hotel-Austria Trend offers a taxi service: €35 for up to three persons + €10 for each additional person. Please contact the hotel direct.

By car:

Coming from **Vienna/Graz** - Follow the E57/A9 road until the Beljak/Villach/Kranj exit - exit and take the H3 - after 4.3km turn left onto Dunajska Cesta - after 220m turn right on Ogrinceva and then the first left - after 280m turn left and then left again on the Dunajska Cesta - after 260m you will find the Austria Trend Hotel Ljubljana on your right.

Coming from **Carinthia** - Follow the E57 until the Exit Gradec/Graz/Maribor/Ljubljana-sever - exit and take H3 - after

4km take the 3rd exit (direction Ljubljana-Center) - after 350m turn right onto Dunajska cesta - after 220m turn right onto Ogrinceva and then immediately the first left - after 280m turn left and then immediately left on the Dunajska cesta - after 260m is the Austria Trend Hotel Ljubljana on your right.

Coming from **Trieste** - Follow the A1/E61 road and follow the signs for Ljubljana - take the exit for Ljubljana-sever and drive onto the H3 - after 4km take the 3rd exit (direction Ljubljana-Center) - after 350m turn right onto Dunajska cesta - after 220m turn right onto Ogrinceva and then immediately the first left - after 280m turn left and then immediately left on the Dunajska cesta - after 260m is the Austria Trend Hotel Ljubljana on your right.

Directions Garage Hotel Ljubljana:

Coming from the south motorway, take the Stukljeva cesta - turn left on the Dunajska cesta then the first right and immediately the first left - after 280m turn left - and then left again on the Dunajska cesta after 260m is the Austria Trend Hotel Ljubljana on your right.

Hotel parking is available at €1.50 for 1 hour, €15 for 24 hours, €4 = overnight parking (19.00-07.00).

Delegates can also use the parking garage at 162 Dunajska street, approximately 200 metres to the hotel.

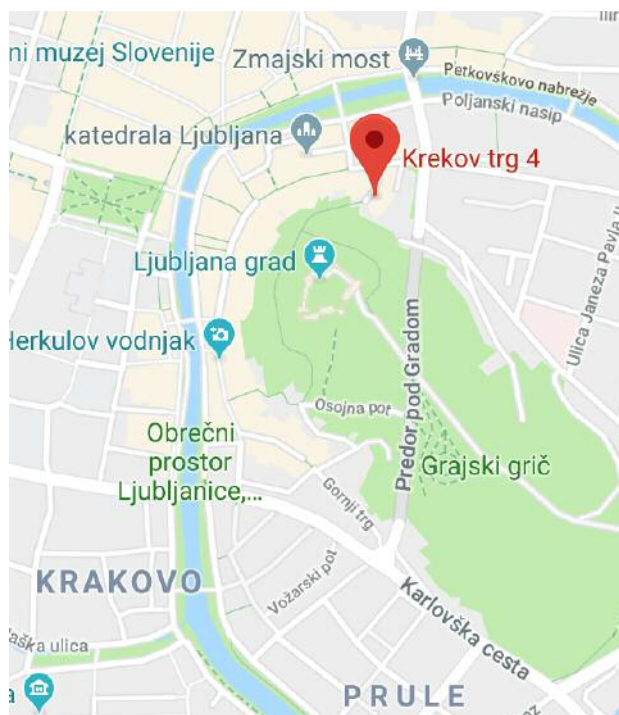
CONFERENCE WORKPACK & APP

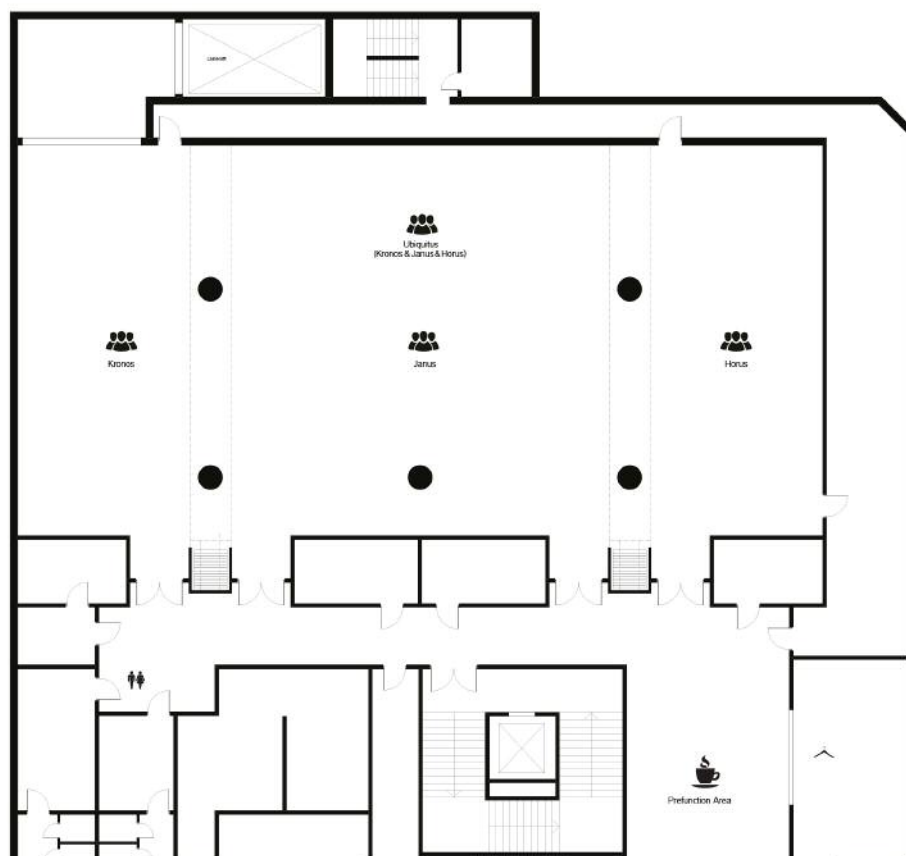
