INSOL 2018 Americas Annual Regional Conference 29th April – 1st May

INSOL International Technical Paper - Adequate Protection for Secured Creditors in the Context of the Proposed EC Directive on Preventative Restructuring

On 22 November 2016, the European Commission published a proposal for a directive "on preventive restructuring frameworks, second chance and measures to increase the efficiency of restructuring, insolvency and discharge procedures". This paper focused on certain aspects of the provisions in the proposal dealing with preventive restructuring frameworks, more particularly the stay of enforcement proceedings by secured creditors against assets of the debtor and the protection that secured creditors may be entitled to in respect of such a stay. This paper looks at the provisions in chapter 11 of the US Bankruptcy Code dealing with "adequate protection" for secured creditors, as well as recent amendments to the Singapore Companies Act and assesses whether the European legislator should consider introducing the concept of "adequate protection" in the proposal.

INSOL International / World Bank Africa Roundtable (ART) 9-10 November 2017, Mauritius

ART 2017 was our eighth full Africa Roundtable hosted jointly with the World Bank. The project has grown from strength to strength since its inception in 2010, and this year we had 107 attendees, with an additional 52 on the second day.

As with last year's ART, the first day was invitation only to government officials, judges, regulators and key policy makers; and the second day was opened up to practitioners and academics for a small fee. Adam Harris, INSOL President, was chair of the meeting and the committee. The committee also consisted of representation from our partners in the project, the World Bank Group and from key African jurisdictions, including Mauritius, where the Roundtable was held.

This year's ART theme was 'Plugging the implementation gap", which was proposed by the World Bank as they have found this to be a major obstacle for jurisdictions who have reformed, or are about to reform. Sessions included: 'After a Secured Transactions and Insolvency Law: What Next?'; 'Straight from the source: why an insolvency law is not used.'; 'Building institutional capacity.'

The first day ended with the 'Insolvency Skills Workshop', developed by PwC Africa, in which participants were given basic insolvency facts prior to the forum and divided into teams to work through the case from the perspectives of the various stakeholders. This is one of the highlights for delegates and this year was no exception.

INSOL International PRC Half Day Seminars 26 September 2017, Beijing 28 September 2017, Shanghai

The PRC half day seminars were held successfully in Beijing, for the sixth time, and Shanghai for the fourth time. The seminars have simultaneous English-Chinese translation as the majority of the population do not speak English.

The Beijing seminar was kindly hosted by King & Wood Mallesons and attracted 62 participants, and the Shanghai seminar, kindly hosted by EY, attracted 77 participants. Attendance numbers were lower this year than previous years due to IPs and lawyers having to finish their work ahead of the Communist Party Conference taking place on the week of the 16th October. Despite this, the Main Organising Committee thought it was the best programme yet.
