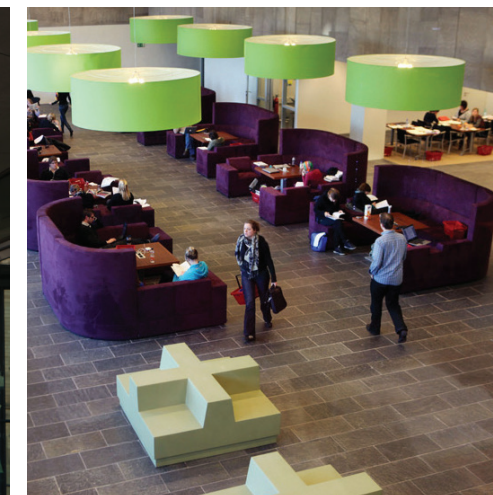
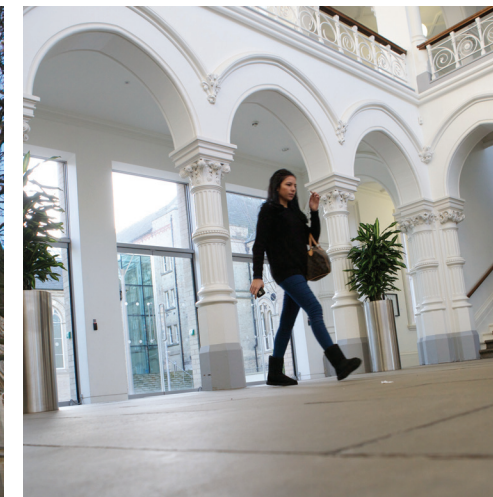

Nottingham Law School, England and Radboud University, Nijmegen, The Netherlands have become partners to offer an exciting and innovative dual Master’s in Law degree. At the end of one year of study, successful students will be awarded the LLM Corporate and Insolvency Law from Nottingham Law School and the LLM European and Insolvency Law from Radboud University. Students spend time studying for the dual LLM at both university campuses. The partnership between the two universities means that internationally recognised professors of insolvency law, all specialists in their specific fields, will teach and share their extensive knowledge and expertise with students on this programme.

Radboud University

Radboud University in Nijmegen is one of the leading academic communities in The Netherlands. Established in 1923 and situated in the oldest city in The Netherlands, it has seven faculties and enrolls over 18,000 students.

The University prides itself on its personal style of teaching and the opportunity to work closely with academics and fellow students in small seminar groups. This makes it easy to meet other students and ensures effortless integration into the local community.

One of Radboud University’s most pleasing features is unquestionably its green campus, generally regarded as the most attractive campus in The Netherlands.

Faculty of Law

Programme

This dual LLM programme is designed for students who wish to develop their understanding and knowledge of Corporate, Insolvency and European law for a legal career with a strong European and international focus.

The modules taught at both campuses are presented in English, and students will enjoy the benefits of being taught by experts from both Nottingham Law School and the Faculty of Law at Radboud University. Lecturers from both universities will be at the Radboud University campus at the start of the course to welcome students, and to ensure that they quickly settle into student life.

The programme is taught at the Radboud University campus in Nijmegen during the first semester from September to the end of December. Students then move to Nottingham Law School in Nottingham, and are taught there until early May. The LLM thesis / dissertation can be completed at either campus. Two of the modules on the programme are full year modules and are studied partially at the Nijmegen campus, partially at the Nottingham campus, and partially online through the Nottingham Trent University online workspace (NOW).

Entry requirements

You are required to have **one** of the following:

- a Dutch Bachelor’s degree (or equivalent, from a research university) in law and knowledge of the basic concepts of international or European Law (as established by the Examinations Board).
- a UK undergraduate degree in Law (2.2 or above) or, an honours degree in another discipline plus either the CPE (Common Professional Examination) or GDL (Graduate Diploma in Law) conversion qualification.
- A recognised undergraduate degree in law equivalent to either of the above qualifications.

International student language requirements

In order to study on this programme you need to have a sufficient level of English. Non-native speakers of English, without a Dutch Bachelor’s degree or VWO diploma, need one of the following:

- an IELTS score of at least 6.5; or
- a Cambridge Certificate in Advanced English (CAE) or Certificate of Proficiency in English (CPE) with a mark of C or higher.

International student visa requirements

It is imperative that all students check the visa requirements for studying in the Netherlands AND the United Kingdom. A visa granted for The Netherlands does not automatically allow applicants entry into the United Kingdom, and vice versa. Students must therefore ensure that they meet the visa requirements of both countries when applying for a place on this dual programme, and must also ensure that applications are submitted in plenty of time before the commencement of modules at each campus.

International students will be required to have a valid visa for studying in both The Netherlands and in the UK. As the programme commences in The Netherlands international students will start the programme before applying for a UK tier 4 visa. Students commence studies in the UK on 12 January 2015 and can therefore apply for a UK visa from 12 October 2014 onwards. Details of visa requirements can be found here:
