Claim Priorities in Rescue Proceedings – A Global Compendium

INSOL International is very pleased to have published an electronic book titled "*Claim Priorities in Rescue Proceedings – A Global Compendium*", a copy of which was sent to all INSOL members in December 2016 and is also available for members to view/download online.

The compendium consists of priority and special issues relating to various classes of claims across 23 jurisdictions and is presented in a user friendly-chart format that shows the (i) types of claims (ii) description about these claims and (iii) comments from the contributors relating to these claims. The claim types would include secured; administrative; priority; unsecured; equity interests, etc. In addition, certain claim types with special rights or issues such as inter company claims, labour/employee claims; pension claims; governmental claims; etc. are also covered.

We envision the compendium as a basic reference and valuable tool for any practitioner involved in cross-border insolvency matters who wants an overview of how particular types of claims will be treated in foreign jurisdictions. With time, this publication will be expanded to include more countries and the country chapters will be updated as and when necessary.

Statement of Principles for a Global Approach to Multi-Creditor Workouts

As previously advised, the INSOL Lenders' Group has worked to review and update INSOL's seminal publication "Statement of Principles for a Global Approach to Multi-Creditor Workouts", first published in 2001. We are pleased to advise that endorsement of the Principles in their revised form has recently been received from both the World Bank and the Bank of England. The revised Statement of Principles will be launched in March 2017 at INSOL Sydney.

The Long (or Not So Long) Arm of Avoidance Claims: The Issue of Extraterritorial Application

By David Molton of Brown Rudnick LLP, Fellow, INSOL International and Jacob Beiswenger of O'Melveny & Meyers, USA (*Posted on 4th October 2016*).

In the context of cross-border insolvency proceedings, an office holder's avoidance powers are among the most important tools available to maximise creditor recoveries. Although one might expect the 'avoidance' remedies of a sophisticated insolvency regime to have clear and undisputed extraterritorial effect and application, this is far from the case. The application of avoidance powers in the cross-border context is fraught with choice-of-law complications.

This paper examines the situation in the US and UK and highlights recent case law in both countries regarding the extraterritorial application of avoidance powers, with often conflicting results.

The paper concludes that a global rule, akin to the one now being employed by the European Union, based upon applying the avoidance law of the jurisdiction where the debtor has its "centre of main interest" may avoid piecemeal application of a particular bankruptcy regime and minimise the fraudulent removal of otherwise avoidable transfers from the range of avoidance prosecution in any jurisdiction.

Assignment of Non-Performing Loans (NPLs) – Main Challenges in Brazil

The stock of NPLs in the portfolios of financial institutions throughout Brazil has grown exponentially in recent years due to the increased availability of credit and higher default rates caused by the current macroeconomic scenario. Brazilian financial institutions are increasingly seeking to assign these NPLs with the intention of clearing their balance sheets and this growing market for NPLs has attracted the attention of both international and local investors.

This paper provides a comprehensive analysis of the current market for NPLs in Brazil and the constraints imposed on it by the applicable regulations and legislative requirements for both assignments of and after-sale management of NPL portfolios. It makes comparison with two other international markets: firstly, the US, which is considered to be the most developed market for NPL transactions and secondly, Spain, a market with some similarities to Brazil.

The 10th Forum of Asian Insolvency Reform (FAIR) Conference held in Hanoi, Vietnam on 21 to 22 November was a tremendous success. Approximately 150 delegates from throughout Asia attended. FAIR was hosted by INSOL International in conjunction with the Supreme Court of Vietnam and The World Bank. Neil Cooper, Past President, INSOL International, expertly facilitated the two-day meeting. Mark Robinson, INSOL President had the pleasure of welcoming delegates to FAIR.

UNCITRAL Working Group VI (Security Interests), 30th Session 5-9 December 2016, Vienna, Austria

INSOL Past Presidents Neil Cooper and Sijmen de Ranitz attended the Working Group session as observers on behalf of INSOL International. In accordance with the practice established in UNCITRAL, INSOL's delegation was invited to the session to represent the views of our organization on matters where it has expertise or international experience so as to facilitate the deliberations of the Working Group.

INSOL EDUCATIONAL PROGRAMMES

INSOL International / World Bank Africa Roundtable (ART) 6-7 October 2016, Accra, Ghana

ART 2016 was our seventh full Africa Roundtable held jointly with the World Bank. The project has grown from strength to strength since the first meeting in 2010, and this year we had 90 delegates representing 17 African countries, as well as representation from OHADA.

Whilst ART started as a closed meeting by invitation only to government officials, judges, regulators and key policy makers, following the success of last year, we opened up the second day to practitioners and academics for a small fee, which facilitated wider discussion. Adam Harris, INSOL Vice-President was chair of the meeting and committee. The committee also consisted of representation from our partners in the project, the World Bank Group and representatives from key African jurisdictions including GARIA, our member association in Ghana.

This year's ART theme was "*The freedom to fail: Insolvency for micro, small and medium enterprises*", which explored the importance of addressing MSME insolvency, in a manner that still upholds creditor rights and promotes access to finance. Sessions included Designing an Insolvency regime for MSMEs; Access to Finance and Insolvency Reform; Cross-border Insolvency and the Role of the Insolvency Regulator.

The first day ended with the "Insolvency Skills Workshop", developed by DLA Piper together with Judge Elizabeth Stong, US Bankruptcy Court, in which the participants were given basic insolvency facts prior to the forum and divided into teams to work through the case from the perspectives of the various stakeholders. Each group included a judge who ruled on the case presented to him or her. As always this practical workshop was a highlight of the programme.

Yet again ART was a resounding success, as reflected in the feedback and comments from participants.
